



DESCRIPTION

Domestic violence is a pervasive public health issue. This course examines how domestic violence may be defined, the prevalence of domestic violence, and the intersection between intimate partner violence, stalking, and homicide. Screening/assessment strategies and interventions that may promote safety and stabilization for victims/survivors of domestic violence will be explored. Resources available to assist victims/survivors of domestic violence will also be discussed.

OBJECTIVES

Upon completion of this course, the participant should be able to:

1. Define domestic violence.
2. Discuss the prevalence of domestic violence.
3. Describe the intersection between intimate partner violence, stalking, and homicide.
4. Describe screening strategies for domestic violence.
5. Explain at least two interventions that can be used to promote safety and stabilization for victims/survivors of domestic violence.
6. Identify resources available to assist victims/survivors of domestic violence.
