PROGRAM DESCRIPTION:

Description:

This course will give us the opportunity to look at boundaries and the role of health care professionals. We will explore the inevitable and occasional crossing of boundaries with a goal of gracefully re-establishing boundaries.

Objectives:

Upon completion of this program, the participant should be able to:

- ◆ Define relationship boundaries.
- ◆ Identify when boundaries are crossed.
- ◆ Identify patient goals and prioritizing.
- ◆ Discuss differentiating patient goals from those of our own.
