## **DESCRIPTION**

Ethical dilemmas are part of anyone's practice in the behavioral health field. Often though, we find that the code of ethics in our area of licensure is quite different from our coworkers. This can lead to misjudgment of our colleagues and confusion on the part of our patients. In this training, we will look at the different types of ethics, the differences between the code of ethics for different behavioral health providers, and how to deal with ethical issues, from reporting to responding. Ethical dilemmas will be presented and discussed throughout the training.

1. Differentiate the "Who, What, When, Where, and How" of professional ethics.
2. Identify the four types of ethics.

4. Report an ethical violation and how to respond should a complaint be made about them.
