### Week 1: SCRIPTS - South Carolina Reporting & Identification Prescription Tracking System

#### August 7, 2025 / 10:00-11:00 a.m. via virtual Webex

**Goal:** Increase basic knowledge of what data the SC PMP houses, SC PMP mandatory use Statutes, and interpreting patient reports.

**Objective:** Achieve an increased awareness of the monitoring and analyzing of data with controlled substance prescriptions and dispensing and help to identify potential problems like doctor shopping and high-risk prescribing.

Instructor: Dr. Chelesa Townsend, PhD, CRC

Dr. Chelsea Townsend is the Director of the Prescription Monitoring Program (PMP) for South Carolina. Dr. Townsend graduated from the South Carolina College of Pharmacy in 2015 with a Doctor of Pharmacy degree. Upon graduation, she began working for Rite Aid, and subsequently Walgreens. In the community pharmacy setting, Dr. Townsend focused on direct patient outcomes through Medicare MTM, various immunization initiatives, and assisting in naloxone protocol procedures. In 2021, she onboarded with the SC Department of Public Health's Bureau of Drug Control to start her current role. Dr. Townsend is a member of multiple national organizations involving prescription monitoring programs and chairs or co-chairs multiple national committees and subcommittees. Additionally, she is a member of the South Carolina Opioid Emergency Response Team (OERT) and the OERT Data Subcommittee.



# Week 2: Simple, Safe, Legal: Narcan® and the Law

#### August 14, 2025 / 10:00-11:00 a.m. via virtual Webex

**Goal:** Session 2 will cover information on how to respond to a potential overdose in the community, and the laws protecting bystanders who take action to save a life.

**Objective:** Participants will increase knowledge on where to get Narcan and the law regarding Narcan.

#### Instructors: Jessica Owens, MA LAC AADC MAC, Chief Operating Officer and Kristy Abd-El-Malak, Assistant Solicitor

Jessica Owens is a Licensed Addictions Counselor, Advanced Alcohol and Drug Counselor, and Master Addictions Counselor who serves as Chief Operating Officer at the Phoenix Center. Jessica has a Masters in Human Services with a focus in Marriage and Family Counseling from Liberty University and a Bachelors Degree in Psychology from Clemson University. She has a vast knowledge of substance use disorder treatment throughout the treatment continuum. Jessica has experience working in multiple settings such as traditional adult/adolescent outpatient treatment, office-based opioid treatment, residential treatment, withdrawal management, and community harm reduction work. Jessica is a strong believer in person-centered and trauma-informed approaches in helping individuals meet their goals.

Kristy Abd-El-Malak is a first-generation lawyer practicing in Greenville County. She graduated from The College of Charleston with a BA in English and Political Science. After graduating, she took a year off to work at the 13th Circuit Solicitor's office. She then graduated from Wake Forest University School of Law where she obtained her JD law degree. Kristy currently works at the 13th Circuit Solicitor's office as an Assistant Solicitor where she primarily prosecutes drug crimes ranging from minor possessions to trafficking charges. She is the chair of the Drug Court program committee for the Solicitor's office, member of the ECHO Community Action Team, and is currently working on a project to help deflect high school students from paths of criminality. Kristy is passionate about the law, justice, and rehabilitation for drug-users.



### Week 3: An EMS Perspective of Overdose

#### August 21, 2025 / 10:00-11:00 a.m. via virtual Webex

Goal: Increase knowledge specific to EMS and overdoses.

**Objective:** Participants will increase knowledge around Emergency Medical Services in Greenville County and understand how Emergency Medical Services respond and document overdoses.

**Instructors:** Phil Head III, MS, NRP, FP-C, CP-C, Director of Clinical Services with Greenville County EMS, and Jonathan Peeples

Phil Head III is currently serving as the Director of Clinical Services with Greenville County EMS and is responsible for many divisions to include all primary and continuing education, quality review and assurance, the community paramedic program, clinical investigations, and hospital relationships as well as serving a senior leader of the organization driving positive culture and changes. Previously, Phil served as the Manager of EMS Education for Prisma Health and was responsible for the EMT education training and certification for all the incoming medical school students. Phil also assisted with a variety of simulation experiences and prehospital education training as needed. Prior to coming to Prisma Health, Phil served as the Department Head/Academic Program Director for the EMT/Paramedic program at Greenville Technical College. Phil has a variety of EMS experience to include rural and urban 911, field training and preceptor training. Phil worked as a flight paramedic for 7 years with GHS Med-Trans here in Greenville South Carolina. Phil has a bachelor's degree in health science from the Medical University of South Carolina and a Master of Science in Health Administration from Liberty University. Phil has served at Columbia College for the last three years and is currently teaching the Psychological and Social Dimensions of Disasters.

Jonathan Peoples NRP, CP-C Jonathan is a Nationally Certified Paramedic and Certified Community Paramedic with over 20 years of experience. He has worked at Greenville County EMS since 2007. After many years on the ambulance, Jonathan has now been in the role of Community Paramedic since 2019 and has primarily worked with underserved populations. Over the past few years he has helped develop and implement several programs for EMS to engage with vulnerable populations and provide linkage to care. He has a passion for harm reduction and stigma reduction and is always looking for ways to help those in need.



# Week 4: Stimulants, is it Opioids 2.0?

#### August 28, 2025 / 10:00-11:00 a.m. via virtual Webex

**Goal:** Better understanding of the controlled substance prescribing system.

**Objective:** Participants will increase their knowledge of the SC substance prescribing system and increase knowledge of the current increase in stimulant use.

**Instructors:** Dr. Walker, M.D., FASA, Medical Director for Division of Pain Medicine, Department of Anesthesiology

Dr. Kevin B. Walker is currently the Medical Director for the Division of Pain Medicine with Prisma Health—Upstate Affiliate. Dr. Walker, a native of South Carolina, completed his undergraduate studies at Wofford College in Spartanburg, SC, where he majored in Biology. From there, Dr. Walker attended the Medical University of South Carolina in Charleston, SC, where he obtained his medical degree and completed a residency in Anesthesiology. After residency, Dr. Walker continued his training at Vanderbilt University, earning his fellowship in Interventional Pain Management. Upon completion of the fellowship, Dr. Walker returned to upstate South Carolina and began private practice in anesthesia and pain management. After nearly 6 years in private practice. Dr. Walker joined Prisma Health, where he has developed a Pain Division within the Department of Anesthesiology and Perioperative Medicine.
