Mandated Reporting: Protecting Our Older Adults



DESCRIPTION

Mandated Reporting explores the many facets of the SC Department of Social Services Adult Advocacy/Adult Protective Services Division. It looks at the law and mandates that govern Mandated Reporting and how that relates to the philosophies and practices of APS. It also looks at the concept of "vulnerability" and how competency and capacity plays a role in determining it. Finally, It discuss the "can and cants" of APS and how that impacts service coordination.

OBJECTIVES: Upon completion of this course, the participant should be able to:

- **1.** Identify and have a better understanding of the law that governs Mandated Reporting.
- **2.** Understanding of the who, what, and why in reporting.
- **3.** Understanding of how competency and capacity play in determining vulnerability and reporting.
